With a background in general engineering specialising in Energy & Environment, I have gained experience in waste management and then in the refrigerant sector. I closely followed the revision of the European F-gas regulation and was responsible for the work carried out by the EPEE Task Force on LRM.

I finally joined Climalife in January 2025 to strengthen the circular economy team with Laurent Guégan, Circular Economy manager and president of ADC3R (French association of companies Distributing, Filling (ADC) Recovering and Reclaiming Refrigerants (3R)).

Samuel is passionate about innovative ways of value creation, sustainable access to value, and inclusive economic growth. His interest in policy, finance and business models stems from his work in the African cold chain where the preservation of food for safe human consumption is not only an engineering and economic activity, but one that addresses an environmental and humanitarian crisis.

He is currently the programme lead for South Africa's demonstration pilot programme to phase-out hydrochlorofluorocarbons (HCFCs) out of refrigeration and ventilation systems and introduce natural refrigerants as part of South Africa's obligation towards the Montreal Protocol. Samuel works with the United Nations Industrial Development Organization (UNIDO) and The Department of Forestry, Fisheries and The Environment (DFFE) on this national programme.

Energy Partners Refrigeration: Cooling systems are essential in a range of applications like airconditioning, vaccine preservation, food production, industrial processes, and data centres. However, they do contribute to GHG emissions and with the global commitment to sustainable energy solutions, Energy Partners Refrigeration's mission is to realise a sustainable change in the way cooling energy is understood, funded, and consumed in the world.

My top 3 priority for the COPA SC work:

- 1. Promote the dialogue on an inclusive transition from ODS & HFC technologies for end-users at base markets.
- 2. Identify/ develop business models to unlock Private Sector participation in base markets for a technology transfer.
- 3. Strengthen government participation w.r.t policy framework development and monitoring and enforcement thereof.

ADRIAN BUKMANIS Steering Committee Candidate – private sector: VERIDIEN REFRIGERANT MANAGEMENT

I came to understand the problem of refrigerant emissions after founding an energy efficiency firm in Southeast Asia. By working with cooling and refrigeration projects on the ground, I developed an appreciation for the multitude of challenges that exist. With this experience and awareness, I decided to focus solely on the environmental issues related to refrigerants.

I believe within COPA we have much of the knowledge, tools and collective experience available to address the problem. We know largely what needs to be done. We need to pull together quickly behind the right efforts, those that are backed by science and are going to deliver maximum environmental gains in the quickest steps

Veridien (Singapore, Australia): provides advisory, training and technology for life-cycle refrigerant management. We offer services to help develop accurate inventories, emissions calculations and leak mitigation. We place a strong focus on refrigerant selection using natural refrigerants to avoid increasing HFC and HFO banks and tracking their use through end-of-life. My top 3 priority for the COPA SC work:

- 1. The number one objective must be containment (alongside preventing the banks growing). To prevent all fluorinated refrigerants reaching atmosphere. Whether from cooling or foams. Recovery and containment puts the emergency brake on the problem and buys time to further develop EOL solutions.
- 2. Ensuring that we don't re-invent the wheel. There has been lots of good work done already that can be built on and leveraged. The priority is speed, and to work out what can be delivered quickly with maximum impact (best bang for buck)
- Working on ways to ensure the longevity and effectiveness of COPA. There are many climate solutions battling for attention. I believe it is important to find new and innovative ways to raise the awareness and profile of the organization, and the critical work that still needs to be done.
